DISCRIMINATION ON THE BASIS OF SEXUAL ORIENTATION AND GENDER IDENTITY IN MEXICO CONTINUES TO BE A STRUCTURAL PHENOMENON WITH EXTENSIVE SOCIAL ROOTS.
