DISCRIMINATION ON THE BASIS OF SEXUAL ORIENTATION AND GENDER IDENTITY IN MEXICO CONTINUES TO BE A STRUCTURAL PHENOMENON WITH EXTENSIVE SOCIAL ROOTS. THE SITUATION FOR LGBTIQ ASYLUM SEEKERS IS EXTREMELY DANGEROUS AS THEY ARE FORCED TO WAIT IN DANGEROUS MEXICAN BORDER CITIES WHERE HOMOPHOBIA AND TRANSPHOBIA ARE RAMPANT AND CASES OF KIDNAPPING, SEXUAL ASSAULT AND VIOLENCE ARE COMMON.
